Please note: This is a rain or shine event. Event Planners, with the assistance of local law enforcement, reserve the right to cancel the paddling portion of the event due to inclement weather. In the case of a cancellation, an announcement will be made and all participants may meet at the Seneca Falls Recreation Center for awards and celebration.

The undersigned, _____, a participant in the CANAL CRAWL event sponsored by the Seneca County House of Concern, does agree to waive any claims he/she may have against it as follows:

1. In recognition of the risk of injury while participating in the Canal Crawl, I hereby for myself, my heirs, executors, assigns or personal representative knowingly and voluntarily enter into this waiver and release of liability and hereby waive any and all rights, claims, or causes of action of any kind arising out of my participation in the Canal Crawl and hereby release and forever discharge Seneca County House of Concern (Hereinafter referred to as "Sponsor"), and its affiliates, members, agents, attorneys, employees, volunteers, representatives successors and assigns, the Canal Crawl site, all sponsors, from any and all liability, claims, damages, actions, or causes of action now existing or which may arise as a result of my Canal Crawl participation, whether any injury is caused by negligence of the Sponsor, the negligence of myself or third parties, the conditions of the course, the conduct of the Canal Crawl, or any other cause.
2. I attest that I am physically fit and have trained sufficiently for the Canal Crawl.
3. In the case of thunder and lightning, I agree to get out of the water and follow storm precautions.
4. For safety reasons I agree to wear a US Coast Guard approved personal flotation device with whistle or noisemaker at all times while I am participating in the Canal Crawl.
5. I will refrain from using headphones and/or cell phones during the Canal Crawl.
6. I will refrain from the consumption of alcohol for the duration of the event.
7. I grant the right to take photographs of me and my property in connection with this event. I authorize the Seneca County House of Concern, its assignees and transferees to copyright, use and publish the same in print and/or electronically. I agree that Seneca County House of Concern may use such photographs of me with or without my name and for any lawful purpose, including for example such purposes as publicity, illustration, advertising and Web content.
8. I acknowledge that this agreement is the entire agreement between the Sponsor and me, and that this agreement cannot be modified except in writing signed by the Sponsor and myself.
